Mr. George Baker (Parliamentary Secretary to Minister of State (Fisheries)): 1. The Canadian delegation to the Canada-U.S. Salmon negotiation session, held in February, 1974 comprised: C. R. Levelton (Head of Delegation), Director General, Operations Directorate, Fisheries and Marine Service, Department of the Environment. M. P. Shepard, Director, International Fisheries Policy, International Fisheries and Marine Directorate, Fisheries and Marine Service, Department of the Environment. B. Applebaum, Legal Operation Division, Department of External Affairs. L. H. Legault, Director General, International Fisheries and Marine Directorate, Fisheries and Marine Service, Department of the Environment. W. R. Hourston, Regional Director, Pacific Region, Fisheries and Marine Directorate, Department of the Environment. In addition, advisers and experts from the Federal and Provincial Governments, (Province of B.C.) and the B.C. fishing industry attended the negotiations.

2. No further negotiations have taken place since February 1974, although officials to the two governments have

been in contact from time to time to discuss elements of the problems. There have also been a number of meetings with the Canadian industry advisory group to discuss the Canadian position. It is expected that negotiations will resume early in 1976.
