### Petitions

I ask the Prime Minister to take some action on this publicly and to continue with the Canadian tradition which has been a non-partisan one. Mr. Trudeau, whom he invited to play a role in the Commonwealth, has a distinguished reputation in this field which all Canadians recognize. All Canadians, of whatever Party, recognize that Canada has played a constructive role, not simply by going along in a pre-established consensus among western countries in these matter, but from time to time speaking out in fair and clear terms to both superpowers. If we want some movement to take place on the part of both of them at Geneva next month, I say simply to the Prime Minister that time is short. Just as he called for the superpowers themselves to take that extra setp, I ask him to take that extra step himself and put before the superpowers the necessity of moving within the framework of the framework about which I have just talked.

Time is short. If we do not move in this kind of direction soon, if nations around the world do not join in on putting pressure on both the superpowers, and if we do not move on this important matter now to take that extra step for once, it may be perfectly correct to say that tomorrow will be too late.

I conclude by welcoming the Prime Minister back and by welcoming his constructive efforts at the UN and in the Commonwealth. I hope that he, too, will take that extra step which he is calling upon Washington and Moscow to take.
