That gives a certain perception to the viewing audience which I believe to be inaccurate and unfair. At the same time those of us on this side could in supplementary questions accuse the government of being erroneous in its facts. I am wondering where this will lead us to.

Mr. Speaker: The hon. member has asked if the Speaker would comment on the use of the word erroneous. I might but I think I would prefer to wait until I have the full context of how the word was used and the circumstances under which the complaint was brought, because words in themselves without the context are not always the best guide to members.
