AT CLEVELAND

Aspirants for Championship
Awarded Game by 9 to 0
Forfeit — Umpire Owens' Decisions Objected To.

Chicago, Sept. 9.—With the score at 3 to 0, Umpire Owens forfeited today's game to the Chicago White Sox 9 to 0 in the tenth inning because of the discriminatory tactics of the Cleveland players. As a result Chicago is now seven games ahead of Boston in the pennant race.

The Cleveland players protested Owens' ruling in the tenth when, with two men on base and no one out, he called Grane out in a close play at third base. The game was delayed for ten minutes because of arguments. When the Cleveland players finally resumed play, they hurled their gloves in the air and two or three of them rolled into the dirt to express their displeasure.
