THE NEWS IS OMINOUS

The French-British War Scare Has Been Revived.

A REQUEST TO NEWSPAPERS.

The New French Cabinet Complete—The Dreyfus Dossier Inspected by Counsel for the Family—A German Proposal About China—The Philippines to Be Taken by the U.S.

London, Nov. 1.—The Daily Mail this morning publishes no news regarding England's war preparations, explaining that silence is due to a letter from the War Office, asking it not to publish "anything which might be useful to a possible enemy."

Another significant event. London, Nov. 1.—Most of the papers are full of alleged war preparations, despite the official fact that the authorities are doing their best to prevent the location, and even denying statements that have already appeared. Yesterday a sudden outbreak of French troops, an experimental mobilization of the defense force. All the heights and forts were smartly occupied in a manner giving all satisfaction.

The arsenal at Woolwich is working until 11 o'clock every night. The Government is having large orders for guns, searchlights and other naval equipment. The British Channel squadron has cast anchor off Gibraltar.

The advice from Paris in the special despatches this morning regarding the situation at Fashoda. It is believed that Capt. Barter is taking only verbal instructions for Major Marchand.

The idea prevails at the French capital that Count Muraviev, the Russian Foreign Minister, while there on his recent visit promised Russian support in repelling the whole Egyptian question, and that Major Marchand will be instructed to fall back and maintain his occupation of all Bahri-Ghatal posts.
