and renumbering subsequent subclauses accordingly.

After further debate, the said motion was, by unanimous consent, withdrawn.

By unanimous consent, Mr. Alexander, seconded by Mr. Thomas (Moncton), moved,—That Bill C-229, An Act respecting Unemployment Insurance in Canada, be amended by adding next after subclause (1) of clause 4, following line 35 on page 5, the following:

"(2) The Commission may, with the approval of the Governor in Council and subject to affirmative resolution of Parliament, make regulations for including in insurable employment any person who is employed or otherwise engaged in a business within the definition of "business" in the Income Tax Act."

and renumbering subsequent subclauses accordingly.

After debate thereon, the question being put on the said motion, it was agreed to.

By unanimous consent, Mr. Mackasey, seconded by Mr. Macdonald (Rosedale), moved,—That Bill C-229 (Reprinted as amended and reported by the Standing Committee on Labour, Manpower and Immigration) be amended (a) by striking out line 32 on page 5 thereof and substituting therefor the following:

'thereto'

(b) by deleting lines 35 on page 5 and substituting therefor the following:

'consent thereto; and'

(c) by adding immediately following paragraph (f) of sub-clause 1 of clause 4 on page 5, the following paragraph:

'(g) the tenure of an office as defined in the Canada Pension Plan'

After debate thereon, the question being put on the said motion, it was agreed to.
