Inquiries of the Ministry

Hon. J. J. Greene (Minister of Agriculture): The government's program as announced entails a basic distribution of functions as between federal and provincial responsibilities. Inasmuch as the provinces already exercise a responsibility for quotas and price levels of fluid milk the fluid milk producer and his support are clearly and primarily a provincial responsibility. I believe that the distribution of responsibilities, with the provinces assuming the responsibility for support of the fluid milk producer and the federal government assuming responsibility for the support of the manufacturing milk producer, will in the long run serve the best interests of the dairy farmers of Canada.

Mr. Olson: Could the minister tell the house what he has heard from those provinces which have no subsidy program for surplus fluid milk? Will the federal or provincial governments give relief in the near future to take care of this deficiency, now that the subsidy has been removed?

Mr. Greene: Mr. Speaker, of course I cannot speak for the provinces. I believe that all provinces or provincial agencies set the price of fluid milk, and that either the provincial government or one of its agencies sets the quota. If any province in its wisdom, as happened in Ontario this past year, feels that it wishes to subsidize fluid milk producers at figures over and above their production quotas, and basic prices, that of course is a decision that must be made by that province's government.

Mr. H. A. Moore (Wetaskiwin): Is the minister aware that this new policy is causing an increase in the price of bottled milk sold on the street?

Mr. Speaker: Order, please. That is an argument and not a question.
