Inquiries of the Ministry

have something to say about the other subject [English] later. I should like to ask the right hon. gentleman whether he is still planning to attend the prime ministers' conference and, if so, whether he is giving consideration to supporting mandatory sanctions against Rhodesia under the United Nations charter.

Right Hon. L. B. Pearson (Prime Minister): Whether I am able to attend this conference will depend on developments in the house and in the country in connection with the railway situation. I would regret very much, of course, if I were not able to go. In the circumstances I do not think I should say anything about what I might do if I were able to go, but before the conference opens there would be, I hope, an opportunity on orders of the day or on motions for whoever represents Canada to make a short statement.

Right Hon. J. G. Diefenbaker (Leader of the Opposition): I realize that the Prime Minister is most anxious to attend, and it is very desirable that he should be able to attend the prime ministers' conference. I want to say to the right hon. gentleman that anything we can do to make it possible for him to be there for a couple of days will be done; because, I suggest, his presence there is very necessary at a time when the future of the commonwealth might well be in jeopardy unless, in the collective wisdom of the prime ministers, a consensus is arrived at.

Mr. Pearson: I can only say I appreciate very much the attitude taken by the right hon, gentleman. I still hope it will be possible for me to attend this conference, even if for only a couple of days. His attitude, expressed this afternoon, will make this easier.

Some hon. Members: Hear, hear.

VIET NAM-RECENT DISCUSSIONS WITH U.S. PRESIDENT
