### NATIONAL CAPITAL INQUIRY AS TO POSSIBLE ABOLITION OF COMMISSION

**Mr. Gaston Isabelle (Hull):** Mr. Speaker, I wish to direct a question to the Minister of Forestry and Rural Development, who has jurisdiction over the National Capital Commission.

In the light of reports which have been circulated since yesterday in press circles, can he tell us if the National Capital Commission will be soon abolished?

Hon. Jean Marchand (Minister of Forestry and Rural Development): Mr. Speaker, as far as I know, no decision has been taken to that effect. A tripartite report has been forwarded to the federal government and to the governments of Quebec and Ontario, but no decision has been taken and the news or the rumour is unfounded.

**Mr. Gilbert Rondeau (Shefford):** I would like to ask a supplementary question, Mr. Speaker.

As the Minister has insinuated that the structures of the National Capital Commission will be modified, can he tell us whether the province of Quebec will be consulted about these changes, given the financial contribution it will undoubtedly have to make?

Mr. Marchand (Langelier): The province of Quebec is always consulted, Mr. Speaker.

VANCOUVER, B.C.—EMPTY SHIPS LEAVING PORT
