Hon. Léo Cadieux (Minister of National Defence): 1. The price of one uniform consisting of one cap, one jacket, one pair of trousers, one shirt and one tie is \$48.00; however each individual will receive a uniform kit consisting of the following new items, the estimated value of which is \$170.00: 1 cap, 2 jackets, 2 pair of trousers, 4 shirts, 2 ties, 1 overcoat and scarf, 1 raincoat regular, 1 raincoat lightweight.

Hon. Léo Cadieux (Minister of National Defence): Mr. Speaker, the answer to the first part of the question is that the term appointment of Mr. Michael Godfrey of College Militaire Royal de Saint-Jean terminates on August 15, 1969 and will not be renewed.

The following is the answer to the third part of the question: The decision of the Director, College Militaire Royal de Saint-Jean, has been the subject of a grievance by Mr. Godfrey which was heard at the deputy minister level and the decision was to deny the grievance.
