URBAN AFFAIRS**LOANS TO MUNICIPALITIES BY CENTRAL MORTGAGE AND HOUSING CORPORATION—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION**

Mr. Léonel Beaudoin (Richmond): Mr. Speaker, pursuant to Standing Order 43, I request the unanimous consent of the House in order to discuss a matter of urgent and pressing necessity.

Since the Central Mortgage and Housing Corporation, under its program of loans to municipalities for the establishment of water and sewage systems, wishes to help low income Canadians anxious to buy a house; since there is now a very strong demand for houses, and procedures to be followed by municipalities to obtain such loans are often long and arduous, I move, seconded by the hon. member for Shefford (Mr. Rondeau):

That the House consider in the shortest delays the possibility of revising procedures to be followed in order that municipalities may obtain more easily and rapidly loans from the Central Mortgage and Housing Corporation for the establishment of community water and sewage systems.

HOUSING**INDEMNIFICATION OF PURCHASERS OF BADLY CONSTRUCTED HOUSES—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION**

That this House examine as soon as possible the action required so that the Ministry of Urban Affairs be empowered to grant subsidies to certain buyers who are nothing less than victims of a disaster whose property needs urgent repairs.
