complains because the Liberals entered into an agreement with Ford which did not include any protection and did not guarantee the number of jobs; it was a piece of botchery, debauchery, on the part of the Liberals. Anyway, he is not around here to tell us what action to take or what action he is taking.

Last fall, Mr. Speaker, hon. gentlemen opposite wanted a budget. My, it is amazing how things change when people move just a few feet across the floor of this chamber. They demanded a budget. Why? The present Minister of Justice had this to say on October 23:

It is important that the nation know where it stands. I hope the Minister of Finance will tell us what he is thinking and what he intends to do.

That is why they wanted a budget last fall. I refer to page 517 of *Hansard*. The former minister of finance went on to give various other reasons and, as reported at page 516, he said:

We have to get ready to move now rather than push back all the problems until later.

I could read his whole speech and the reasons he gave. The hon. member for Windsor West also gave his reasons for demanding a budget, as reported at page 950 of Hansard for November 5, but I will not put on record all the reasons they gave then for demanding a budget. Why do they not talk, now, to this reluctant debutante, the present Minister of Finance? He does not want to bring in a budget. Why does he not want to let the nation know where he stands? I will tell you. Mr. Speaker. It is because when the nation finds out where he stands, the nation will know that he stands on sand. The nation is not going to like where he stands. The nation is not going to like what it hears; it is not going to like the tax measures he is going to bring in unless his oil blender can go to work and save him somehow by getting the billions of dollars of revenue he needs. From where? Is he going to take his blender out to the tar sands? Has the Minister of Energy, Mines and Resources got some magic blender he intends to set up way out on the tar sands and start blending to get us the oil we need at a reasonable price?

The Minister of Finance is waiting because he is pinning his hopes on the Minister of Energy, Mines and Resources, and a more unlikely magician I never saw. "Mandrake the magician" has nothing on that gentleman. When Premier Lougheed gets through with him you will not be able to pick him up with tweezers. But he has to pull off this miracle. Because if you are not going to impose an excise tax on gasoline, which would have helped Canada, which would have helped conservation, which would have been the way the IMF recommended to the governments of the western world, and if you are not going to get the \$2.5 billion in revenue which a measure of that kind would produce, then the revenue has to be obtained from somewhere else. And as the President of the Treasury Board has said, the only way to bring down the deficit is to increase revenue.

I wish him well, if he ever attempts it. Here is what the member said as reported at page 2299 of *Hansard*, when he was discussing my budget:

If that little guy decides to have a smoke or a drink to try to find some solace from the document brought in by the Minister of Finance of the Liberal government, he is going to find that the price of his cigarettes is up, like the cost of his tobacco, his wine, his beer and his hard liquor. That is exactly what the Minister of Industry, Trade and Commerce as finance critic last December 12 opposed; he got up in this chamber and opposed it.
