Question No. 4,945—Mr. McKenzie:

- 1. Was the Minister of Industry, Trade and Commerce notified of the opposition by Canadian truckers to the imposition of 12 per cent duty on importation of heavy duty reefer units?
- 2. Will the Minister instruct the Machinery and Equipment Advisory Board to be discretionary in granting Canadian truckers remission of duty on importation of such units and, if not, will the Minister conduct an investigation to determine the effect upon the Canadian truckers of the 12 per cent duty?
- 3. Is the Minister aware of concern expressed by Canadian truckers with regard to after-sales service on heavy duty reefer units and, if so, will the Minister instruct the Board to ensure reliable and easily accessible after-sales service on such units?

Hon. Ed Lumley (Minister of Industry, Trade and Commerce and Minister of Regional Economic Expansion): 1. Yes.

The Machinery and Equipment Advisory Board has examined carefully the capabilities of the new Canadian manufacturer of truck refrigeration units and is satisfied that it meets all requirements of the Machinery Program. The Board is monitoring the progress of the company in establishing itself in the marketplace. The trucking industry has been advised that quick action can be taken to re-establish duty remission, when appropriate, in the event that the Canadian manufacturer is not able to supply the demand placed upon it.
- 3. Yes. The Board is satisfied that the Canadian supplier has the capability to service these units. The company currently has service centres located in nine major cities across Canada.

LISTING OF CONSUL GENERAL IN BOSTON TELEPHONE DIRECTORY

Question No. 4,951—Mr. Stewart:

- 1. Was the Consul General for Canada listed in the Boston City Guide under "Visitors Information" as "Consulat General du Canada, 500 Boylston Street, 267-9330"?
- 2. Was the advertisement placed only in French in Boston, an English-speaking city, and, if so, for what reason was it not placed in English and French?
- 3. Who was responsible for placing the advertisement and under whose direction was it done?
 - 4. What was the cost of placing the advertisement?

Hon. Allan J. MacEachen (Deputy Prime Minister and Secretary of State for External Affairs): It is correct that the Canadian Consultate General in Boston is listed in the Boston City Guide solely in the French language. However, the listing was done without any consultation with the Canadian Consultate General in Boston, and no payment was made by the Consulate General in connection with the listing. The listing was made solely by decision of the editor of the Boston City Guide who obtained the information from the French language listing of the Consultate General in the Boston Telephone Directory. (The Consultate General is listed in both English and French in the Boston Telephone Directory.) The Consultate General has advised the editor that its listing should be in both Canadian official languages and the editor has agreed that this will be done in future publications.
