PRESENTATION OF FOURTH REPORT OF STANDING COMMITTEE

Mr. William C. Winegard (Guelph): Mr. Speaker, I have the honour to present the fourth report of the Standing Committee on External Affairs and International Trade.

The report has a common introduction, a common background section, a very large section concerning the witnesses whom we heard and the broad spectrum of opinion, and a relatively short common ground section. Then there are three reports: A majority view, a minority view of the Liberal Party, and a minority view of the New Democratic Party. I believe it represents the spectrum of opinion that is in the country and perhaps in this House.

And, that the Speaker shall adjourn the House at the ordinary hour of daily adjournment.

PROPOSED FREE TRADE

Mr. Nelson A. Riis (Kamloops—Shuswap): Mr. Speaker, it is my privilege, indeed, honour, to present a petition on behalf of a number of westerners who indicate that the Conservative Government has no mandate from the Canadian people to conclude a free trade agreement with the United States and are concerned that the proposed trade agreement would deny Canada the policy freedom to determine its own economic future and will undermine our ability to build a society distinct from that of the United States.

They point out that the agreement denies Canadians the secure access to the United States market which was the key objective in these negotiations, but threatens the loss of hundreds of thousands of Canadian jobs.

Therefore, they are calling upon Parliament to dissolve and allow the people of Canada the opportunity to accept or reject the proposed free trade agreement during a national general election.
