Saturday afternoon, July 21, 1888 the Nationals shut-out the visiting Truro aggregation. Waggs, the local twirler, held his opponents to a couple of safeties, while his team mates were driving out nineteen singles, two doubles and two triples. It was a veritable slaughter of the innocents. Twenty-four runs were the result of the slaughter, and such a phenomenal score had not been known in part in years. In the second inning the locals made seven runs and in the last nine they had a total of 22 stolen bases to their credit. The game went two hours and ten minutes. Umpire Morton L. Harrison.

Connolly threw the ball to Costigan at second and he dropped it. A passed ball gave the visitors another chance, and combined with placing of hits, the first four men crossed the plate. The game ended five to four in favor of the Halifax players.

A HEDGE OF ROSES.

Seven Million Two Hundred Thousand
Growing on It.

Los Angeles, Cal., April 23.—Seven million two hundred thousand roses are blooming on a single hedge surrounding a thirty acre orange grove near this city. The estate is owned by J. L. Matthews, chairman of the County Board of Forestry, when the blossoms indicated nearly double the quantity of previous seasons.

The hedge is eight feet high and four feet across the top. In it are La France, La Marquette, Henrietta and Papa Gontier varieties. The property is owned by George W. Griffith. Matthews figured the total number of buds by carefully counting them on a section. So far as known, no other groves on one hedge, even in Southern California, where they grow in greatest profusion.

Last Night's War Cables

London, April 27, 10.30 p. m.—

On the narrow, rocky Gallipoli peninsula in Turkey, and on a restricted front stretching northward from Ypres in Belgium, two of the most vital struggles of the war are now in progress. Neither has yet reached a stage which would permit of a prediction of the ultimate result.

In the Gallipoli peninsula a picturesque assortment of Allied troops landed Sunday, supported by the fire of the warships and are trying to batter their way through thousands of German-occupied trenches in an effort to force the Dardanelles—the main gateway of the Ottoman empire—and reach Constantinople.

Melbourne, via London, April 27, 11.03 p. m.—It is officially announced that a British warship has captured the German trawler, steamer, *Edfride*, which is believed to have been the last German ship free in the Pacific.

London, April 28, 8.38 a. m.—A despatch to the Morning Post from the North of France says that a Zeppelin visited Calais Monday and dropped numerous new type of bombs of greatly increased power. The bombs included thirty civilians. A fleet of aeroplanes visited Amiens without serious damage.

\$3,000,000 IN 24 HOURS.

London, April 27, 9.35 p. m.—The appeal of the British Committee for Relief in Belgium has resulted in \$3,000,000 being collected in less than twenty-four hours. New South Wales contributed \$184,720. The Lord Mayor of Melbourne's fund aggregated \$100,000.
