Sparkling Specimens of Wit and Wisdom

Gathered in the Westminster Skating Rink Last Night,

As They Were Lavishly Let Fail by Local Conservative Orators.

Between 200 and 300 people braved pneumonia and asylumania at the Essery meeting in Westminster Rink last night, and sat with their coats and hats on and shivered while the speakers delivered their addresses. The temperature in the rink was very cold, and many people had to leave on that account before the meeting closed. The seating accommodation provided consisted of the two dozen seats that the city hall is noted for. Mr. Ed. Flock occupied the chair and was succeeded later by Mr. J. A. Thomas. On the platform were Henry Macklin, Thos. H. Smallman, Ald. Taylor, J. A. Thomas, E. Meredith, Geo. Pritchard, P. H. Bartlett, Ald. Coo and Mayor Essery.

MR. E. MEREDITH. Mr. Meredith is the man who "sized up" Mr. Essery last January, and it was his first appearance in public in favor of the candidature. Among other things, Mr. Meredith said: "This man (Sir Oliver Mowat) is the humbug that has been paraded throughout the country for the last

twenty years." "To defeat Mr. Essery money will flow like water. Gentlemen, money will come down from Toronto to defeat Mr. Essery. Why, gentlemen? Because if they do not defeat Mr. Essery they are defeated themselves. Last election lying and money spending was nothing. They were determined to defeat Mr. Meredith. Emanuel T. Essery, small in statue though he is, will be returned on the 20th of this month, as sure as you are here, by a majority of 400 or 500.

J. A. THOMAS. Mr. Thomas, among other things, said: Any man ought to be sick of Sir Oliver Mowat and his prating. A hypocrite dis-gusts me, and of all people he is one of the worst. A Toronto Widow Sues a Coachman for \$5,000 Damages.

Japanese Outcast. DENVER, Nov. 15 .- "Strangler's Row" was the scene of another murder Monday. About 1:15, 1,975 Market street was visited by the fiend whose hobby is to choke women to death, and when he left the Kiku Oyama, a Japanese girl, who ran the place, was a corpse, with the marks of the strangler's work upon her throat. This murder was committed in the same row of houses in which Lena Tapper and Marie Comassoit were strangled. The mode of her death, too, was exactly similar. After partially choking her the crime was completed by tying a towel around her neck and tightening the noose until life left her

SAD FATE OF A SCHOOLBOY. Caught by a Falling Window and Slewly Strangled to Death.

MARION, Ill., Nov. 15 .- A 12-year-old son of R. J. Morray met his death in a singular manner at a school house a few miles southeast of this place late this atternoon. Upon his arrival home from school the lad discovered that he had left his gloves at the school house. He immediately returned for them, but found the door locked. From the surroundings it is supposed he procured a piece of timber, which he placed against the wall of the building to assist him in climbing in through the window. When found a few hours afterwards his body was hanging from the window, his neck having been caught between the sash and the sill. He had evidently climbed upon the timber, raised the lower sash and tried to make au entrance, when the timber slipped from under his feet and the sash fell and caught his feet when found.


