The resolution to extend the time for manufacture, importion and sale of oleo-margariae in Canada was passed in the Commons and the bill introduced.

The St. Catherines Evening Journal suspended publication Saturday because of the steadily increasing cost of material and advancement in wages. The paper was established in 1859.

Quite a few U.S. citizens are looking Ontario License Board ruled that renters of cottages are entitled to import liquors from Montreal.

The next assessment for the province of Ontario will probably show that the rural population will be less than 960,000 while the urban population will be at least 1,575.000. In 1886 the population of rural Ontario was 1,148,000, but it has been decreasing steadily ever since.

The U. S. custom service asked two million dollars to pay 1000 additional men to keep liquor from coming across the border from Canada, but Congress refused to make a further grant and thought it time to call a halt on the meaning cost of prohibition of which six million dollars has previously been word voted.

In 1919, Ontario had out of a total of 5,757 rural schools, five schools with an average attendance of one pupil; 12 schools with an average attendance of two; 35 schools with five; 479 schools with six, and 1,400 schools with

less than ten pupils. Ma.l Order Business Discussed In Senate

The effect of mail order houses upon local merchants was brought to the attention of the Senate at Ottawa, recent-by by Senator Proudfoot. Senator Proud-foot said that when in the Ontario Legis-lature he had advocated each municipal-ity placing a tax on mail order houses for ity placing a tax on mail order houses for the right to sell goods in the municipal-ity. Local merchants received their goods by treight and the rates had been twice raised since 1918, once by 15 per cent., and once by 25 per cent., while the postal rates had not been increased, so mail order houses were able to ship catalogues and goods through the mails at the old rates. He understood that ity placing a tax on mail order houses for at the oid rates. He understood that these goods were carried for the mail worder houses at less than the cost of transportation, and in this way the Gov-ernment was bonusing the operation of mail order houses by millious of dollars mail order houses by millions of dollars anually. He was the more ready to be-lieve this because the Postmaster-General had stated in the Commons within the past few years that newspapers were carried at less than cost, and that the Government in this way was bonusing the newspapers to the amount of six million dollars a year He had no ob-jection to this being done for the news-ranger done for the newspapers, because they were educational, but this could not be pleaded for the mail order business houses. If, as he believed the mail order houses were being served by the post office at less than cost, the sooner a change was made the better.

SENT UP FOR TRIAL


