Will the minister undertake to transmit to the seaway authority a copy of last Thursday's *Hansard* with a covering letter indicating his approbation of the expression of opinion by the house on the question of the seaway tolls?

**Mr. Pickersgill:** I think the seaway authority are regular subscribers to *Hansard* and do not need to have their attention drawn to it by me.
