Question No. 2,355-Mr. Coates:

Are accurate lists of living Canadian recipients of Royal Honours maintained and (a) if so, by what department and are they available to the public (b) if not, for what reason?

Right Hon. P. E. Trudeau (Prime Minister): Records have been kept of the names of Canadian recipients of orders and decorations conferred by the Sovereign, extending back over many years. Whenever information comes to hand about the decease of holders of such honours, the records are amended but deaths are often not reported nor found in obituary notices. Hence, the records are necessarily incomplete. (a) Until 1972, records of honours were kept by the Secretary of State Department but are now held in the Honours Secretariat, Government House. Information is supplied to the public in response to specific inquiries concerning holders of these honours. (b) See answer to part (a).

CONSULTATIONS BETWEEN MOT AND PROVINCIAL GOVERNMENTS—GROS MORNE NATIONAL PARK

Question No. 2,455-Mr. Marshall:
