- Hon. E. F. Whelan (Minister of Agriculture): 1. Copies of speeches delivered by the Minister of Agriculture for Canada were printed, and distributed, at public expense, on October 12 and October 13, 1973. The speeches were not political addresses, in the partisan political sense, but reviews of policies, programs and proposals. (a) 1,995 copies were prepared, 1,460 in the English language and 535 in the French language. (b) The direct cost was \$189.79. (c) The copies were distributed to 1,845 people. (d) The copies were distributed to members of the news media and the public who have specifically asked the Department of Agriculture to provide them with the text of all prepared speeches delivered by the Minister of Agriculture. Anyone who requests copies may obtain them by applying to the Information Division of the Canada Department of Agriculture.
- 2. The Minister of Agriculture for Canada has delivered up to October 15, 1973, 57 prepared speeches. This number is one-tenth of the number of speeches he has been requested to make. Every speech made has been distributed to the news media and public. The Minister of Agriculture has delivered most of these speeches on week-ends or Wednesday nights.

With respect to the answer to Question No. 2,322, what are the names of those officials of the government presently represented on the International Committee operating under the auspices of the American Bureau of Shipping to investigate technical matters concerning submersibles and what are their responsibilities within the Department?

- Hon. Jean Marchand (Minister of Transport): 1. The Ministry of Transport representative for technical matters concerning submersibles on the American Bureau of Shipping Special Committee on Submersible Vehicles is Mr. W. E. Bonn. Mr. Bonn is Superintendant, Hulls Inspection and Standards, Steamship Inspection, Marine Safety, and his responsibilities are as follows: Under the direction of the Chief, Steamship Inspection Division of the Marine Safety Branch at Ottawa Headquarters, organizes and controls the planning, development and co-ordination of departmental programs covering the inspection of ships' hulls, structural fire protection systems, assignment of load line, damaged and undamaged stability, flooding and heeling systems and associated machinery and equipment, programs for the design and approval of ships subdivision, and the design and operation of ships in Arctic waters; provides direct supervision to assigned staff at headquarters and functional supervision to field inspection staff.
- 2. The above-mentioned committee consists of 31 members from both industry and government and has representatives from five countries, viz., U.S.A, Canada, Switzerland, France and the United Kingdom. Canada is represented by five members from the industry, the Canadian Armed Forces and the Ministry of Transport. The book "Guide for the Classification of Manned Submersibles" produced and presently being modified has been the subject of the two meetings held since January 1972. The standardization of external adaptors is a high priority item for the next meeting, tentatively planned for early December 1973.
