# FIRE ALARM SYSTEMS AND PROCEDURES IN GOVERNMENT BUILDINGS

Question No. 5,165-Mr. Cossitt:

1. Did the Dominion Fire Commissioner address a letter dated February 6, 1976 to Mr. David Morley, a Deputy Secretary of the Treasury Board on the subject of concern on the part of Mr. C. A. Edwards, President of the Public Service Alliance of Canada, of fire alarm systems and procedures in government buildings?

2. Did the letter state in part "as a result of the fire protection equipment installed, testing procedures and training of personnel in government owned or leased buildings, we feel that the protection provided far exceeds that provided in the private sector for similar occupancy"?

3. What is a detailed description of the (a) testing procedures (b) training programme for personnel in government owned or leased buildings followed by the Dominion Fire Commissioner?

4. Is a complete descriptive list of all fire protection equipment installed in public buildings maintained by the Dominion Fire Commissioner and (a) if not (i) for what reason (ii) can the Dominion Fire Commissioner properly function without such information (b) if so (i) since what date has such a list existed (ii) can such a list be readily and immediately produced and made available for public scrutiny?

5. Do government owned or leased buildings receive inspections (a) for fire prevention (b) of fire alarm systems by the Dominion Fire Commissioner and, if so, how often?

### Hon. C. M. Drury (Minister of Public Works): 1. Yes.

2. Yes.

3. (a) Testing procedures for installed fire protection equipment are listed in the Fire Protection Engineering Standards of the Dominion Fire Commissioner. Copies of these standards are available from the Department of Public Works. (b) The training program for personnel in government owned or leased buildings is outlined in the Dominion Fire Commission Fire Protection Standard No. 14 and Dominion Fire Commissioner Guidelines for Phased Evacuation Training. Copies of both publications are available from the Department of Public Works.

4. No. It is not considered essential for the Dominion Fire Commissioner to maintain a list of installed equipment.
(a) (i) The Department of Public Works, Property Administration Branch maintains such a list for maintenance purposes in all federal buildings; (ii) Yes. Testing of all equipment is carried out during the inspection of buildings; (b) (i) Not applicable; (ii) Such a list may be obtained from the Property Administration Branch of the Department of Public Works.

5. (a) Yes; (b) Yes, during scheduled inspection at five year intervals.
