REPORT OF COMMITTEE OF SELECTION—CORRECTION

Hon. T. D'Arcy Leonard, with leave of the Senate, moved:

That the report of the Committee of Selection presented to the Senate on December 19, 1968, be corrected by adding the names of the Honourable Senators O'Leary (Antigonish-Guysborough), O'Leary (Carleton) and Quart to the list of senators nominated to serve on the

Committee on Internal Economy and Contingent Accounts.

CANADA SHIPPING ACT

BILL TO AMEND—SECOND READING

The Senate resumed from Thursday, December 19, 1968, the adjourned debate on the motion of the Hon. Mr. Langlois, for the second reading of Bill S-23, to amend the Canada Shipping Act.

Hon. Jacques Flynn: Honourable senators, this is a thick bill, consisting of 18 pages, and the sponsor Senator Langlois, when introducing it, indicated that it contained only urgent amendments to the Canada Shipping Act that could not await the further revision of the act, which he told us was presently in process.
