Mr. BORDEN (Halifax). I would like to ask the Minister of Finance (Hon. Mr. Fielding) when he expects to bring the estimates down?

The MINISTER OF FINANCE. Very shortly.

Mr. BORDEN (Halifax). And may I ask when we are to expect the Auditor General's Report ?

The MINISTER OF FINANCE. I am afraid I shall have to make further inquiry on that point. We are pressing it forward by all possible means, but at my last inquiry the document was not complete. I shall be able to tell my hon. friend (Mr. Borden) at the next sitting.

Mr. BORDEN (Halifax). With the indulgence of the House, I would like to ask whether the hon. gentleman (Hon. Mr. Fielding) suggests that we should go into supply before the Auditor General's Report is down. I think it would be very inconvenient to do so—I can hardly see, at present, how it will be possible to do so. Perhaps the hon. gentleman will be able to give us to-morrow the date when we may expect the Auditor General's Report.

The MINISTER OF FINANCE. I will do my best to give the hon. gentleman a statement to-morrow. Meantime, the formal steps with respect to supply, taken at the first of the session, are being taken; and, within a day or two, we will let the hon. gentleman know what further steps will be taken

state the departmental reports are. The lateness of these reports last year delayed the business of the House for months. It is inconvenient, in fact it is impossible, to properly discuss the estimates and to reach conclusions with regard to the matters that come before us, until we have these reports. If these reports come before the House at an early day, it will be a gratification to us on this side to assist the government to put through the business of the House as promptly as possible.

The MINISTER OF FINANCE. My hon. friend (Mr. Wallace) will find no cause of complaint on that score.
