## REQUEST FOR DELAY IN TERMINATION OF EXPRESS SERVICE IN SASKATCHEWAN—MOTION UNDER S.O. 43

**Mr. Ray Hnatyshyn (Saskatoon-Biggar):** Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. In light of the announcement by Canadian National Railways of its intention to terminate express service in the province of Saskatchewan thereby causing the layoff of a substantial number of employees and the prospect of a decline in express service within the province and the accompanying inconvenience of a great number of Saskatchewan communities, in view of the fact that immediate termination of express service will mean layoffs at the onset of winter when employment opportunities are most scarce and that CN retraining programs commence in the spring, and in the interest of continuing efforts to arrive at an agreement between the province of Saskatchewan and CN to allow for the continuation of CN express service in Saskatchewan, I move, seconded by the hon. member for Swift Current-Maple Creek (Mr. Hamilton):

That this House direct the Minister of Transport to request Canadian National Railways to forestall any termination of existing express service in the province of Saskatchewan until at least next spring.
