NOVA SCOTIA BENEFIT BUILDING SOCIETY AND SAVINGS' FUND—Incorporated by Act of Provincial Parliament.—Secretary and Treasurer, John Burton, Esq.

At the end of the 4th year, July 31, 1854, the funds of this Society netted £28,951 10s. 3d., including Contingent Fund, of £1,822 17s. 8d. These funds are secured by mortgages on real property. The Society is now "Permanent," the "Terminating Constitution" having been altered. The Contingent Fund was divided among the original Shareholders, from No. 1 to No. 762, inclusive, being £2 9s. 8d. a share, who are designated Class No. 1. The Society is in a flourishing condition.
