CORRESPONDENCE BETWEEN DEPARTMENT OF JUSTICE AND W. H. SPROULE, VANCOUVER, B.C.

Mr. MacINNIS:

For a copy of all correspondence, letters, telegrams or other documents, exchanged between the hon. Minister of Justice or any person in the Department of Justice and Mr. W. H. Sproule, of Vancouver, British Columbia.

Mr. GUTHRIE: There are some letters on the file of the Justice department referred to in this motion, but these letters refer only to some of the private affairs of a judge in British Columbia. The public interest is in no way concerned, therefore the government does not propose to produce these letters.
