ST. LAWRENCE RIVER—ARRANGEMENTS FOR MEETING RESPECTING SAFETY

Mr. Frank Howard (Skeena): In the absence of the Minister of Transport I would normally direct this question to his parliamentary secretary, but the intervention of that hon member into the question period

the other day made it obvious he does not know any more than the rest of us. I should like, therefore, to direct my question to the Minister without Portfolio, the hon. member for St. Lawrence-St. George, and ask him whether a telegram has been received today from the representatives of the Canadian Marine Officers Institute and the Seafarers International Union asking specifically for a meeting with the Minister of Transport to talk about safety on the St. Lawrence. If so, what response, if any, has been given? What is to happen with regard to this request?

Hon. John N. Turner (Minister without Portfolio): May I point out to the hon. member that the telegram was sent only by the S.I.U. and not by the Dominion Marine Association. In reply to this telegram, I stated that departmental officials and myself would be meeting in Montreal next week, on March 16, with all the interested parties, including the unions and the shipping industry, to begin a series of meetings on marine safety on the lakes and on the St. Lawrence river.

Mr. Churchill: Would those be conferences or meetings?

Mr. Turner: Meetings at the technical and official level with the interested parties.

Mr. Howard: May I be allowed to point out that I did not say the telegram came jointly from the Dominion Marine Association, but rather from the Canadian Marine Officers Institute and the Seafarers International Union? Could I ask the minister whether he is the only minister who will be in attendance at this meeting or whether the Minister of Transport will be there as well?

Mr. Turner: I will be the only minister present at this particular meeting, but of course the Minister of Transport will be fully aware of what is happening.

## HIGHWAY SAFETY

REQUEST FOR MANDATORY GOVERNMENT SPECIFICATIONS
