Inquiries of the Ministry

Mr. Lang: Mr. Speaker, the grades shipped will be largely No. 2, No. 3 and No. 4 northern wheat, with some quantities of Durum and some quantities of Alberta red winters.

AVAILABILITY OF BOXCARS FOR DELIVERY OF WHEAT

Mr. J. H. Horner (Crowfoot): Mr. Speaker, may I join with the House in welcoming this announcement. I should like to ask the minister whether he can assure the House and the country that boxcars will be made available for the delivery of this wheat inasmuch as they are so badly needed in western Canada?

Hon. Otto E. Lang (Minister of Manpower and Immigration): Mr. Speaker, this matter has been raised a number of times and I have reported on the discussions which have been held between the Wheat Board and the railways and between myself and these bodies, and on the assurance of the railways of the supply of boxcars according to the schedule which has been developed by the Wheat Board for the movement not only of these quantities but of the record quantities of grain we expect to export this year.

Some hon. Members: Hear, hear!

Mr. Horner: I have a supplementary question, Mr. Speaker.

Mr. Speaker: I will recognize the hon. member for Crowfoot, but I notice there are at least 30 or 35 members rising for the purpose of asking questions. We should try to limit the number of supplementary questions. At the moment I recognize the hon. member for Crowfoot.

Mr. Horner: I should like to ask a quick supplementary, Mr. Speaker. In light of the expected deliveries that have already been announced by the minister and the Wheat Board, can the minister assure the House that this commitment will be met, particularly in view of the difficulties at the already jammed ports at the Lakehead and Vancouver?

Mr. Lang: Mr. Speaker, what I can assure the hon. member of is that everything is being done to make sure that any possible difficulty which crops up is in fact met.

RAPESEED—RECEIPT OF TRUCKLOAD DELIVERIES BY SASKATOON TERMINAL

I am advised that the Board of Grain Commissioners issued instructions to the trade under date of October 14 that the inland elevators at Saskatoon and Edmonton would receive rapeseed on a trucklot basis for the account of grain companies. This facility is now in operation.
