**AGRICULTURE****REPRESENTATIONS OF QUEBEC MINISTER TO OBTAIN FINANCIAL ASSISTANCE FROM FEDERAL GOVERNMENT—STUDY OF POSSIBLE INCREASE IN HOG SUPPORT PRICE**

**Mr. Adrien Lambert (Bellechasse):** Mr. Speaker, yesterday I put a question to the hon. Parliamentary Secretary to the Minister of Agriculture and he replied that he would inquire and answer me later.

Here is my question: Could he tell us whether representations were made by the Quebec minister of agriculture to the federal government calling for financial assistance in respect of the provincial program in order to assist producers of hogs, eggs and turkeys in the province of Quebec who are now enduring great hardship?

**Mr. Marcel Lessard (Parliamentary Secretary to Minister of Agriculture):** Mr. Speaker, after checking with the department I realized that the Quebec minister of agriculture did, some time ago, make representations somewhat similar to those of the hon. member for Bellechasse. That goes back to the beginning of October.

**Mr. Lambert (Bellechasse):** Mr. Speaker, I wish to ask a supplementary question.

I would like to know if the Department of Agriculture or the Agricultural Stabilization Board is considering at this time the possibility of increasing the support price of hogs which is now \$24.14.

**Mr. Lessard (Lac-Saint-Jean):** Mr. Speaker, the hon. member undoubtedly knows that there is an Agricultural Stabilization Act which also covers hog prices. If the average price for pork this year is lower than that of previous years,—and that, on a basis of 80 per cent,—there might be a support payment—
