of applications for the provision of harbour and wharf facilities to fishing communities, will the minister make a statement on motions in the House to indicate any changes in public works policy in respect of providing maintenance for wharves and breakwaters and dredging to assist inshore fishermen to maintain their livelihood which is being affected?

Hon. Jean-Eudes Dubé (Minister of Public Works): Mr. Speaker, there is no change in policy. We are continuing to provide the best facilities possible with resources which are not unlimited.

LOCAL INITIATIVES PROGRAM—POSSIBLE PROGRAM FOR CONSTRUCTION OF WHARVES BY FISHERMEN

Mr. Jack Marshall (Humber-St. George's-St. Barbe): Mr. Speaker, I have a supplementary question for the Minister of Manpower. Will he discuss with the Minister of Fisheries and the Minister of Public Works some type of project under the local initiatives program or a similar program to allow fishermen to provide new facilities and to maintain existing facilities in order that they may support themselves in the fishing industry and to provide employment opportunities to prevent the loss of their livelihood?
