## Order Paper Questions

Attainder is described at page 69 of the Twentieth Edition of Erskine May as "the highest form of parliamentary judicature", which would suggest that such a Bill is a Public Bill.

The procedure is an obsolete one in the United Kingdom and has not been employed since the 18th Century. It has never existed in the Canadian practice and I must therefore rule that the Bill is unacceptable.

Mr. Gordon Taylor (Bow River): In view of your comments, Mr. Speaker, I will not move second reading of this Bill, but I will place on the Order Paper another Bill that will meet your objections, I believe.
