MILLS, Hon. DAVID, LL.B (Bothwell.) 2ND MEM.

Sworn as Minister of the Interior Oct. 1876, which position he held until resignation of Govt., Oct. 1878. An unsuccessful candidate for a seat in the Council of Public Instruction. Ont. 1874.
