

POSTAL REGULATIONS.

LETTERS ADDRESSED FROM OR TO PLACES IN CANADA AND THE UNITED STATES, not exceeding $\frac{1}{2}$ oz. in weight, 3 cents, and 3 cents for every additional half-ounce, or fraction thereof. Drop letters, and letters passing between cities and their suburbs, $\frac{1}{2}$ ounce in weight, 1 cent each.

Newfoundland and Great Britain, and all places within the Postal Union, either by Canadian or New York Mail Steamers, not exceeding $\frac{1}{2}$ oz. in weight, 5 cents, and five cents for each additional half ounce or fraction thereof. The above rates must, in all cases, be prepaid by postage stamps.

REGISTERED LETTERS, for places in Canada and Newfoundland, must be prepaid by stamp, in addition to the postage rate, 2 cents each. To the United States and to the United Kingdom, 5 cents each. Registration stamps are not accepted in payment of postage.

RE-DIRECTED LETTERS.—Letters re-directed to places in Canada and the United States without being taken out of the Post-office, are not liable to any additional postage, but if taken from the Post-office and subsequently re-posted, they must be prepaid at least one full rate for Canada, and in full for the United States, in default of which they will be sent to the Dead Letter Office.

POST CARDS.—Post Cards are issued at one cent each, and may be sent to any address in Canada or the United States. Post cards are also issued at 2 cents each for transmission to Great Britain, Newfoundland and to all Postal Union countries. Reply cards two cents each. Nothing must be attached to the card, nor must the card be cut or defaced in any way.

NEWSPAPERS AND PERIODICALS.—Transient Newspapers within the Dominion, the United States, or Newfoundland, one cent per four ounces or fraction thereof. A single paper weighing less than one ounce will be forwarded for $\frac{1}{2}$ cent. Newspapers posted for city delivery must be prepaid $\frac{1}{2}$ cent. To the United Kingdom and all European countries, a cent each newspaper under two ounces. A single paper weighing more than four ounces will be subject to two or more rates of postage.

MONEY ORDERS.—On Money Orders drawn by any Money Order Office in Canada on any other Money Order Office in the Dominion, the commission is as follows:—Not exceeding \$4, 2 cents; \$10, 5 cents; \$20, 10 cents; \$40, 20 cents; \$60, 30 cents; \$80, 40 cents; \$100, 50 cents. No single Money Order, payable in the Dominion of Canada, can be issued for more than \$100; but as many of the \$100 each may be given as the remitter requires. Money Orders, for a sum not exceeding \$50 each, are issued on the United Kingdom, Newfoundland, the United States, Germany, Italy, Switzerland, Austria-Hungary, Roumania, Jamaica (West Indies), the Australian Colonies, Victoria, New South Wales, and Tasmania, British India, Holland, Denmark, Norway, Iceland, Faroe Islands, and New Zealand. The commission on orders payable in the above-mentioned countries is:—For a sum not exceeding \$10, 10 cents; and 10 cents for each additional \$10.

LETTERS AND NEWSPAPERS FOR FOREIGN PLACES.—Letters addressed to each of the following places, 5 cents for each $\frac{1}{2}$ oz.; Post cards, 2 cents; Newspapers, under 4 oz., 2 cents; Book packets, 1 cent per 2 oz.:—Argentine Republic, Austria-Hungary, Bahamas, Barbadoes (West Indies), Belgium, Bermudas, Brazil, British Colonies on West Coast of Africa, British Colonies in West India, British Guiana, British Honduras, British India, Bulgaria, Canada, Ceylon, Chili, Columbia (United States), Costa Rica, Danish Colonies of St. Thomas, St. Croix, and St. John; Denmark, Dominica (Republic of), Ecuador, Egypt, Falkland Islands, France, French Colonies, Germany, Heligoland, Great Britain and Ireland, Greece, Greenland, Guatemala, Hayti, Hawaii, Honduras, Hong Kong, Italy, Jamaica, Japan, Labuan, Liberia, Luxembourg, Mauritius and dependencies, Mexico, Montenegro, Netherlands, Netherlands Colonies, Newfoundland, Nicaragua, Norway, Paraguay, Persia, Peru, Portugal, Portugese Colonies, Roumania, Russia, Salvador, Servia, Spain, Spanish Colonies, Straits Settlements, St. Vincent (West Indies), Sweden, Switzerland, Trinidad (West Indies), Turkey, Uruguay, Venezuela. Letters containing gold or silver, money, jewels or precious articles, or anything liable to Customs duties, cannot be forwarded by post to any of the above Postal Union countries.

To the following places Letters $\frac{1}{2}$ oz. are 10 cents; Post Cards, 2 cents; newspapers, under 4 oz., 4 cents; and Book Packets, for 2 oz., 2 cents:—Aden (Arabia), Argentine Confederation, Brazil, British Guiana, *via* N.Y.; Ceylon, *via* S. F. & E., Hong Kong (including Amoy, Canton, Foo-Chow, Hankow, Ningpoo and Swatow) *via* S. F. India (British), Mauritius and its dependencies, Straits Settlement of Singapore, Perang and Malacca. South and West Australia and Tasmania, *via* San Francisco, letters 7 cents per $\frac{1}{2}$ oz.; newspapers, 4 cents. New South Wales, Victoria and Queensland and New Zealand, *via* San Francisco: Letters, 15 cents per $\frac{1}{2}$ oz., newspapers 4 cents per 2 oz.

MISCELLANEOUS POSTAL MATTER.—Books and Pamphlets, Printed Circulars, Hand-bills Book and Newspaper Manuscript, Printers' Proofs, Maps, Engravings, Sheet Music, Photographs, Seeds, Roots, &c., to any place in Canada or the United States, 1 cent per 4 oz. in weight. Book packets must be put up in wrappers open at both ends. Parcels to places within the Dominion of Canada, "By Parcel Post," 6 c. per 4 oz., or fraction of 4 oz.; limit of weight, 5 lbs., except to Manitoba and British Columbia which is 2 lbs. 3oz. Patterns and Samples not exceeding 24 oz., for places in Canada, 1 cent per 4 oz. in weight, and must be put up so as to admit of inspection. Parcels and sample packages may be registered, fee 5 cents. Patterns and samples of merchandise for places in the United States, subject to the special rate of 10 cents each, prepaid by stamps, and must not exceed 8 oz. in weight. When addressed to places in the United Kingdom, they must be prepaid by postage stamp at 2 cents for the first four oz., and 1 cent for each additional two ounces. The limit of weight for each packet of newspapers, and other miscellaneous matter sent to places included in the Postal Union, is 4 lbs. 6 oz., except Great Britain, limit 5 lbs. Book packets may weigh up to 5 lbs., and for each packet of patterns and samples, 8 ounces.
