STATEMENTS:

Canada is a trading nation. Our goal as a government has been to protect today's markets and to open the markets of tomorrow. It is with this aim that we are pushing forward for an ambitious result in the Uruguay Round negotiations of the General Agreement on Tariffs and Trade (GATT). We achieved this through the negotiation of a Canada-United States Free Trade Agreement. And we consolidated and improved upon this achievement by negotiating the North American Free Trade Agreement. This Agreement:

- improves our access to the U.S. market;
- gives us preferential access to a growing and dynamic Mexican market; and
- ensures that Canada remains a preferred location for both foreign and domestic investors.

Canada's wealth and growth prospects depend on our access to world markets. We are a small nation in terms of population; access to outside markets underpins our economy and standard of living. That is why we negotiated the FTA, and that is why we negotiated the NAFTA.
