BANK OF CANADA ACT

93. The *Bank of Canada Act* is amended by adding thereto, immediately after section 18 thereof, the following section:

Inspection

“18.1 (1) The Bank may require that the Superintendent of Financial Institutions perform, for a specified purpose, an inspection of any financial institution within the meaning of the *Office of the Superintendent of Financial Institutions Act*.

Costs

(2) Where an inspection is made under subsection (1), such costs incurred in relation thereto as in the opinion of the Superintendent of Financial Institutions are extraordinary shall be borne by the Bank."

PARTIE IV

LOI SUR LA BANQUE DU CANADA

S.R., ch. B-2

93. La Loi sur la Banque du Canada est modifiée par insertion, après l'article 18, de 5 ce qui suit :

«18.1 (1) La Banque peut demander au 25 Inspection
surintendant des institutions financières de
procéder à l'inspection d'une institution
financière, au sens de la *Loi sur le Bureau
du surintendant des institutions financière-
res*, pour un motif déterminé. 30

(2) Les frais occasionnés par l'inspection et qui, de l'avis du surintendant des institutions financières, constituent des dépenses extraordinaires sont imputés à la Banque.»
