### FISHERIES

#### AGREEMENT WITH SOVIET UNION RESPECTING FISHING OFF PACIFIC COAST

**Mr. Thomas S. Barnett (Comox-Alberni):** I have a question for the Minister of Fisheries and Forestry. Will the minister advise where matters now stand with respect to the conclusion of the two-year interim agreement with the Soviet Union with regard to the west coast fisheries? What further steps have to be taken in order to bring about the final completion of this agreement?

**Mr. Speaker:** It seems to me that this information might better be given to the House by way of a general statement on motions. However, the minister might like to reply briefly to the question.

**Hon. Jack Davis (Minister of Fisheries and Forestry):** Mr. Speaker, we have a delegation in Moscow at the present time. The main purpose of the meeting with the Soviet government is to sign the agreement which was negotiated late last fall with the support of the industry.

#### GOVERNMENT GRANT TO CONFERENCE ON POVERTY
