REQUEST FOR SIX MONTHS SUSPENSION OF APPLICATION OF NEW DAIRY POLICY—MOTION UNDER S.O. 43

PROPOSED INTRODUCTION OF PROGRAM TO PROVIDE SUMMER EMPLOYMENT FOR STUDENTS—MOTION UNDER S.O. 43

Mr. John Rodriguez (Nickel Belt): Mr. Speaker, I rise to ask the unanimous consent of the House under Standing Order 43 to deal with a matter of urgent and pressing necessity. In view of the fact that the government has eliminated its Opportunities for Youth program and by so doing has eliminated almost 30,000 jobs, or two thirds of its student summer employment and activities program, and in view of the fact that this loss of jobs, coupled with cutbacks in private spending, will cause severe summer unemployment among young people and students-for example, in the Maritimes the loss of 7,000 OFY jobs, coupled with cutbacks in steel, transportation and merchandising industries, will mean student unemployment in excess of 25 per cent this summer—and in view of the fact that recent unemployment figures show not so much that more people are finding work but that more people, especially in the 18 to 24 age group, are being driven out of the labour market by the lack of employment, I move, seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):
