DONKIN COAL MINE

Question No. 1,434—Mr. Crosby:

- 1. Was a proposal made to the government of Nova Scotia to assist in the development of the Donkin Coal Mine in Cape Breton, directly or through the Cape Breton Development Corporation, once exploration work had been successfully completed and, if so, what was the proposal?
- 2. Did the government provide funds to assist in the development of the mine for future fiscal years and, if so, in what amount?
- 3. Who are the officers in the public service responsible for negotiations between the government of Nova Scotia and the government on the mine?

Hon. Pierre De Bané (Minister of Regional Economic Expansin): The response for the Department of Regional Economic Expansion is as follows: 1. It is difficult to say whether a proposal was made to the Government of Nova Scotia or made by the Government of Nova Scotia in respect of the development of the Donkin Coal Mine in Cape Breton. What is public knowledge, however, is the fact that a proposal was discussed for the development of the Donkin Mine through a separate corporation with shareholdings by Consolidation Coal Company of the United States, the Government of Nova Scotia, the Cape Breton Development Corporation (Devco) and with an expression of interest from Alberta.

- 3. The responsibility for coal development in Cape Breton generally rests with the president of the Cape Breton Development Corporation. There have been no negotiations as such between Devco and the province of Nova Scotia in respect of part (1) above.
