## CANADA SHIPPING ACT AND RELATED ACTS

## MEASURE TO AMEND

The House resumed from Wednesday, April 30, consideration of Bill C-75, an Act to amend the Canada Shipping Act and to amend the Arctic Waters Pollution Prevention Act, the Maritime Code Act and the Oil and Gas Production and Conservation Act in consequence thereof, as reported (with amendments) from a legislative committee; and Motions Nos. 5, 6 and 11 (Mr. Angus, p. 12764).

Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, yesterday we were debating motions put forward by my colleague, the Hon. Member for Thunder Bay—Atikokan (Mr. Angus), motions Nos. 5, 6 and 11. These are proposed amendments to Clause 4 of the Canada Shipping Act.

Hon. Members must realize that Clause 4 of the Bill will provide the Government with the authority to recover the cost of providing Coast Guard services. This is certainly a departure from the prior practice. In the past, these services were not charged for. There was no user fee for Coast Guard services. In Clause 4 the Government proposes to impose such charges. Indeed, under the legislation the Minister will have the authority to set the fee, not only for Coast Guard services, but fees for ice-breaking, navigational aids, dredging services, soundings and search and rescue. I ask you, Mr. Speaker, can you imagine what such a move will do to the East Coast, not only to fishermen but to farmers? Can Your Honour imagine what it will do to the economy of the East Coast of Canada? Do Members opposite from Atlantic Canada not realize the drastic affect this measure will have on the livelihoods of their constituents, since all these charges will have to be passed on down the line to the consumer?

We all know the statistics with respect to Atlantic Canada today. There are enough Tory Members sitting in the back benches, silent Tory Members—

Mr. Tremblay (Lotbinière): Some of them.

**Mr. Rodriguez:** I do not want to tangle with the Hon. Member for Lotbinière (Mr. Tremblay). He is the middleweight champion of the House of Commons, and I do not want to tangle with him. He has a wicked left hook. He is a tough customer, just ask his riding association president. I don't want to fuss with that guy.

**Mr. Deputy Speaker:** Order, please. The Hon. Member for Lotbinière (Mr. Tremblay) on a point of order.
