That is why I believe that the Conservatives will not introduce banking legislation. I also believe that the Liberals are very happy about that because they do not want to see their friends restricted.

BRITISH COLUMBIA—LEGISLATION TO ALLOW SALE OF HOSPITALS' ASSETS

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, Premier Vander Zalm's irresponsible Bill 53, which was introduced yesterday, will allow British Columbia hospitals to sell equipment to the private sector and then lease it back. Under this agreement, cash-starved public institutions which have a tax exempt status will sell expensive equipment purchased with taxpayer dollars to the private sector which then uses it as a tax write-off. The taxpayer pays twice.

The Treasurer of Ontario estimates that institutions receive 10 per cent of the benefit while intermediaries receive 90 per cent. The federal Minister of Finance (Mr. Wilson) calls this an inappropriate use of tax dollars. Ottawa and the provinces have agreed unanimously to a moratorium on such sales and lease-backs of assets of hospitals, yet British Columbia ignores this agreement.

This approach to supplementing hospitals' budgets will not address the root cause of under funding of health care. The federal Government has cut \$2 billion from health and education funding. This must be restored, and the Canadian public should know that this kind of B.C. privatization scheme is ripping them off.
