AKWESASNE RESERVE

Mr. Don Boudria (Glengarry—Prescott—Russell): Mr. Speaker, under the provisions of Standing Order 16 I wish to move the adjournment of the House to discuss a matter of extreme urgency, namely, the violence on the Mohawk community of Akwesasne which is partially in my riding.

This violence has resulted in shootings, grenade blasts, arson, beatings, injuries and now the evacuation of hundreds of citizens of the village of St. Régis. Mr. Speaker, as you will know, this community is located less than 50 miles from Parliament Hill. This violation has got to stop. This issue has to be raised publicly in this House now.

RAILWAY ACT

MEASURE TO AMEND

The House resumed consideration of motion of Mr. Lewis that Bill C-26, an act to amend the Railway Act (grain and flour subsidies), be read a second time and referred to a legislative committee; and on the amendment of Ms. Clancy (p. 8227).
