TWENTY-FIRST REPORT

Your Committee has re-examined the Senate Estimates for the fiscal year 1995-96 (Estimates) which it presented to the Senate on December 8, 1994 in its Thirteenth Report. The Report was adopted by the Senate on December 15, 1994.

Your Committee now recommends that the Estimates be reduced as follows:

Estimates Reduction \$ 42.014.993 \$ 1,765,000 (4.2%)

This proposed reduction in the Estimates, combined with the 5.8 per cent reduction made over the three previous years, amounts to a total reduction of ten per cent.

Your Committee has exercised fiscal restraint and intends to continue in this manner. During fiscal years 1992-93 and 1993-94, actual spending by the Senate was reduced by 10 per cent.

Your Committee recommends that it be authorized to identify those areas within the Estimates where spending reductions are feasible. Your Committee notes that these
