DOMINION CHARTER GOVERNMENT

By-Laws

4. Local Provincial Branches. It should be interpreted that they have autonomy subject only to such general conditions as the Dominion Council may wish to impose upon them, and these branches shall have
- I. The Charter Trustees, their duties, and responsibilities:
- Ans. Section 3.
2. The Dominion Council, its composition, functions, and responsibilities.
- Ans. See Section 4. Sub-sections 3. to 7.
3. The Dominion Executive, its composition, functions, and responsibilities. The work in Provincial Branches shall be done through them.
- Ans. See Section 4. Sub-sections 1. and 2.
4. Provincial Branches, their scope, functions, responsibilities and relation to the Dominion Council, and Dominion Executive.
- Ans. See Section 12. noting particularly Sub-section 6.
5. Local Committees or Branches, their organization, functions and financial relation to the Provincial Branches.
- Ans. See Section 12. noting particularly Sub-section 15.
6. Financial responsibilities of :- Dominion Council (a) affects the provinces where of the money. Provincial Branches (b) Local Committees (c)
- Ans. See Section 12. Sub-section 8 for (a) and the latter part of Sub-section 3 of the same Section for (b & c).
7. Meetings of the Dominion Council.
- Ans. See Section 7. Sub-sections I. - (III) (a) of Sub-section 2, and Sub-section 6.
8. Returns from Provincial Headquarters to Dominion Headquarters.
- Ans. See Section 12. Sub-section 4. (latter part)

REMARKS REGARDING ABOVE

WITH COUNTER REMARKS

1. Under each of these general headings of By-Laws there should be stated all that pertains to the subject which it is necessary to mention - e.g. Composition (number of persons and their qualifications), Election or formation etc.

Counter remark The point is clear.

That has been our aim in the draft submitted

2. Under Membership it should be made clear that there can be members of local Committees and Provincial Branches only - that is there can be no members in any Province or locality who are not in the first instance members locally and their fees or contributions no matter to whom sent, must go to the local organization, if such there be, and where there is no local organization, such member, or members should be asked to constitute such.

Counter remark

- We interpret that to mean, that no person may contribute membership fees to a Branch outside of the Province in which they reside, but must have their membership transferred if moving from one Province to another - ?

3. There should be provision made also for "Contributors" who may not desire membership as such.

Counter remark "Insignis" the "Constituted Body" and "Contributory Member"

The point is not clear to us.

While that may possibly be the case, it is the belief of the Committee that contribution by the "members" of any local branches in the Province, the sum of the amount of the contributions of these branches to Provincial Headquarters, will be proper.
