

ONE MORE FUTILE EFFORT

To Settle the Street Car
Strike.

Men Reduce Their Demands One
Cent Per Hour.

The Company Stick to Their
Original Proposition.

The Mayor Causes a Tangle—Better
Accommodation To Be Put On by
Strikers—Company Say They Will
Run a Complete System Again.

Mayor Wilson yesterday received a letter from the street railway men's union, stating that the men would be willing to meet the company. This letter was telephoned to the company, the officials of which thought the missive might be more explanatory. When asked by the company about the matter, the mayor replied that he supposed the men were coming down to the management to accept the company's offer. He said the strikers would meet the company at 8 o'clock. By some mismanagement the strikers' committee did not know that a meeting had been arranged for 8 o'clock, and it was nearly 11 before the last of the committee men arrived at the office of Helmut & Ivey. The company asked the men what they were going to do, and Mr. Frizell said the men had decided to drop a cent in their demands. The company offered 14 cents per hour for the first six months, 14½ cents per hour for the second six months, and 15 cents per hour after one year. The company informed the men that negotiations had been closed; it was not a question of whether or not the men were willing to make further concessions, but whether they were willing to accept the company's offer. It was simply "Yes" or "No." The men were greatly disappointed, as they had understood from the mayor that the company would consider their offer. The mayor was telephoned for, in order that neither the men nor the company should be placed in any false light. He came and explained the difficulty. The offer of the men, however, was not entertained.

WHAT THE COMMITTEE SAID.
One of the committee men, in reply to questions as to what went on in the conference, said: "We offered to take a cent less than our modified proposition of yesterday. The company will do nothing, and we will do nothing. Speaking for some of the men, I can tell you they would starve before they would accept it."

"The compromise," said another, "has not been offered because we thought the men were asking too much, but simply because we believed that the company was sincere in the statement that it could not afford to pay any more."

A third said that if the committee had accepted the company's proposition, the union men would have said, to the committee: "Well, you can accept it; we won't."

NO SETTLEMENT TODAY.

At 11 o'clock this morning the strikers' committee met the company, and the men submitted their offer of last night, wherein they agreed to accept one cent per hour less. The company would make no advance on their previous proposition, and the fight has been given a fresh start.

When Mr. Everett was here he told the committee that they had planted the peg, and wanted the company to walk to it. Now the committee use Mr. Everett's words the other way, and say: "The company have planted the peg and want us to come to it. We walk, but not to the company's peg."

Mr. Smallman declined to say anything about the matter.

Mr. Carr, when seen, said there was nothing to say, but that negotiations were at an end, and that the company would proceed at once to put on a full service whether the people rode in their cars or not.

"Won't the company's action have a tendency to ruin Springfield business next summer?" a reporter asked one of the company.

"Oh, I don't know. Time is a great healer."

"But many unions, lodges and other organizations in the city have passed resolutions pledging themselves to refrain from using the cars."

"Well, they'll forget about that, too."

THE BUS LINE.
The committee this morning arranged to have a complete bus service to all parts of the city, and feel confident that the citizens will back them up, and that if they do the company will have to back down, and lose thousands of dollars. The bus business so far has been worth on an average \$100 per day, and this will be increased when the service is bettered.

Mr. Everett told a reporter that the strikers would find there was no money in the bus business.

NOTES.

A dispatch from Vancouver says the city is invaded by desperate northern thugs. Numerous burglaries and attempted murders have taken place.

A warrant has been applied for by several cheese factorymen for the arrest of Mr. J. C. Warrington, the Montreal cheese exporter, in connection with the recent failure.

The largest passenger engine ever built in Canada has just been completed at the Kingston locomotive works. It is the first of an order of three for the Intercolonial Railway.

John Charlton, M.P., has gone to Washington to attend the adjourned meeting of the international conference. He expects to be absent at least four weeks. He is accompanied by Mrs. Charlton.

The steamer Australia has arrived at San Francisco, seven days from Honolulu. Among her passengers were 30 soldiers afflicted with malarial fever. There is considerable sickness among the troops at Honolulu.

Mr. Jas. A. Smart, deputy minister of the interior, who is now in the west, finds that Galician settlers, who have been in the country less than a year, have already picked up sufficient knowledge of the English language to converse in it.

Felix Rainsville, of Buckingham, Que., went to Brantford about a year ago, part of which time he worked with a bicycle company, and the remainder with the Massey-Harris Company. Monday night, after receiving his pay, Rainsville mysteriously disappeared.

Rev. E. R. Young, B.A., was appointed assistant editor of the Christian Guardian. The new assistant editor is the son of Egerton Ryerson Young, the missionary. His grandfather was Rev. William Young, a pioneer Methodist clergyman. He was ordained in 1896.

The sealing schooner Pioneer is long overdue at Victoria, B. C., from Bering Sea, where she was last reported on Sept. 27, and sailing men believe she has gone down. Her captain was Colin Locke, and the whites in the crew were Steward A. McLeod, of Glasgow; John Hines and J. W. Smith, of Shelburne.

THE PRESIDENT INDORSED

By the Victory of Republicans
in the West.

Free Silver Issue Believed To Be
Buried.

Republicans Win Everything in
Sight in California.

Fusionists Carry Colorado, With a
Democrat for Governor—Both Sides
Claim the National House of Repre-
sentatives—Bloody Work in Texas.

Lincoln, Neb., Nov. 10.—On the results of the election, United States Senator John M. Thurston says: "The sweeping victory in the west, including Nebraska, means the unconditional indorsement of President McKinley's administration, the conduct of the war and his foreign policy. The battle was fought on the straight gold standard platform, and the result, in my judgment, absolutely eliminates free silver as a national issue in 1900. The entire tendency of independent voters is to return to old party allegiance, with permanent gains to the Republican party from the best element of Democracy and Populists."

"This is largely due to the prosperous conditions of agriculture and business generally. The people are satisfied with present conditions."

"In Nebraska the Fusionists early in the campaign practically abandoned the free silver issue, and for a time attempted to maintain themselves by criticism of the conduct of the war. Driven from this, they fell back on the McCleary bill."

"The Republican campaign was very active and aggressive and successfully met the three issues in detail. Above everything else, however, was the patriotic determination to stand by the administration whose victories in war and whose far-reaching and successful foreign policy has won the admiration of christendom."

IN DOUBT.
Washington, Nov. 10.—Yesterday af-

ternoon Chairman Babcock admitted that the next House of Representatives was in doubt. He claims 174 districts sure, with 15 districts in doubt. One hundred and seventy-nine is a majority.

Chairman Kerr, of the Democratic congressional committee, claimed the certain election of 190 Democrats and Fusionists, an opposition majority of 23 and a Democratic majority over all of 5.

TROUBLE IN TEXAS.
Dallas, Texas, Nov. 10.—Tuesday was a bloody election day in Texas. At Hubbard, Steven's county, Rosarie McCarthy, Joseph Ramby and Jefferson Squires were killed, and J. F. McCarty and Riley Squires probably killed. At Steuben, in Hopkins county, R. E. Sutton and George Young were killed. William Young is in jail as a party to the killing of Sutton, who had murdered Young's brother. At Aubrey, Denton county, Deputy Sheriff B. Taylor was shot through the neck by Lee Webb and dangerously wounded. He shot Webb through the leg. At Sheffield, in Trinity county, J. W. Ashfield was killed and his father probably fatally wounded by persons whose names have not been learned. Many minor affairs occurred in various parts of the state as the result of election differences.

A REPUBLICAN SENATE.
The election returns establish with certainty that the United States Senate will have a Republican majority after March 4 next. An analysis of the party changes shows the Republicans gain seven seats from Democrats (California, Delaware, Indiana, New Jersey, New York, North Dakota, and Wisconsin), and one from Populists (Nebraska). They may lose one (Washington), which is in doubt, and gain one in West Virginia, which is also in doubt. The political divisions of the senate after March 4 will be Republicans, 52; Democrats, 27; Populists, 5; Silver Republicans, 4; in doubt, 2.

COLORADO.
The entire Fusion ticket, headed by Charles S. Thomas (Democrat), for governor, is elected by a majority of about 50,000.

CALIFORNIA.
The entire Republican state ticket, with the exception of secretary of state, has been elected, according to Republican claims. The Republicans claim all seven congressmen and the legislature.

James D. Phelan (Democrat) has been re-elected Mayor of San Francisco after a contest of extraordinary keenness.

MICHIGAN.
Pingree (Republican) is re-elected by 40,000 majority. Republicans have elected eleven and possibly all twelve congressmen. The state senate is overwhelmingly Republican, and but few Democrat representatives are elected. Pingree will carry Wayne county by between 3,000 and 5,000. The greatest interest in Detroit centered on the election of sheriff, and the vote promised to be much closer than the Democrats had figured on. Wells ran considerably behind his ticket. At midnight 74 precincts gave Dr. Duff Stewart a majority of 500.

Gen. Arthur Marsh, chairman of the Republican state committee, says the official count will give Governor Pingree a plurality of 100,000—a gain of over 16,000 over the plurality received in the presidential election. The legisla-

ture will be strongly Republican. The entire list of Michigan Republican congressional candidates appear to be elected, although the Democrats still have hopes of carrying the second district, and do not concede the third, eighth and tenth.

NEBRASKA.
Belated returns continue to indicate that Nebraska has turned a political comeback and landed in the Republican column. Hayward (Republican) is likely to carry the state by over 4,000.

UTAH.
The Democrats have elected Roberts to congress, and carried the legislature, which will elect a United States senator.

WASHINGTON.
The latest returns show that the Republican majority in the legislature on joint ballot will be 20.

TESLA PLANS TO RULE THE SEAS

Says He Has a Magical Invention
Which Will Put an End to
Naval Warfare.

New York, Nov. 10.—Nikola Tesla has announced to an invited party of friends at his laboratory on Monday night that by an arrangement which he had patented he expected to make naval war an impossibility.

Mr. Tesla's invention is not a new one. He received patent rights upon it four months ago, but it was not until the war with Spain that he thought of applying the device to war ships.

SPANISH THRONE TOTTERING.

The affairs of the dynasty are going from bad to worse. From talking of its fall as a remote possibility people have begun to speculate as to when the Bourbons will cease to reign. Senor Castelar assures me that not only is the fall of the monarchy inevitable, but that it is not far off. Senor Carvajal, a former minister, tells me he is convinced that the end of the monarchical regime may be expected before Christmas. Gen. Martinez de Campos, who has served in the cabinet during a previous premiership of Senor Sagasta, is hopeful against hope. Yet so convinced does he seem to be that he offers his sword for the preservation of the dynasty.

Gen. Polavieja, to whom the queen regent looks to assume control if the monarchy outlives the present ministry, believes that it will be necessary to shoot Weyler to save the throne. Weyler for his part promises his friends that he will not stop with shooting Polavieja—a first and indispensable measure—but will see to the execution of Gen. Campos. Senor Sagasta and perhaps President McKinley as well.—Madrid cable to the Chicago Record.
