EFFECT ON NORTHERN WILDLIFE OF RADIOACTIVE DEBRIS  
FROM SOVIET SATELLITE—MOTION UNDER S.O. 43

That the Minister of National Defence or the responsible minister outline on motions today what is being done to determine the extent of the contamination and what contingency plans are in place to clean up the debris and minimize the risks.

## PENSIONS

REQUEST FOR EQUAL TREATMENT FOR WOMEN—MOTION  
UNDER S.O. 43

**Mr. Stanley Knowles (Winnipeg North Centre):** Mr. Speaker, I suppose it is too much to hope that some Liberal will not say no, but I shall try anyway—and I shall keep trying until we win. I move, seconded by the hon. member for Oshawa-Whitby (Mr. Broadbent):

That this House calls on the government, now that we are nearing the midway point in the United Nations Decade for Women, to expedite the introduction of legislation to establish equality for women, and that as a step toward this goal special emphasis be placed on pension equality, including full rights for women under the Canada Pension Plan, equal pension rights for all women between the ages of 60 and 65, regardless of marital status, increasing the pensions paid to widows under various government plans to at least 75 per cent, and the continuing payment of pensions granted to widows regardless of any subsequent change in marital status.
