DRURY, CHARLES ALFRED. (East Simcoe.)

S. of Richard Drury, a native of Kenilworth, Warwickshire, Eng., who came to Can. in 1819, and was one of the first settlers in the Co. of Simcoe, and ed. at the Public Sch. and at Barrie High Sch. M., at Barrie, 12 April, 1877, Marian, youngest dau. of John Varley, London, Eng., (she d. 1877). Is a farmer. Has been Reeve of the Tp. of Oro since 1877; a mem. of the Council of Agriculture and Arts Asso. of Ontario since 1878, and was presdt. of that body in 1882, and a dir. of the Ont. Fruit Growers' Asso. Was an unsuccessful candidate for North Simcoe in the Commons at g. e. 1882. First returned to Leg. Assem. for present seat on resignation of sitting member, Oct., 1882. Re-elected at g. e. 1883. Unseated Nov., 1884, and re-elected June, 1885. Re-elected at last g. e. A Liberal.— Crown Hill, Township of Oro, Ont.

DRYDEN, JOHN. (South Ontario.)

Father emigrated from Sunderland, Eng., in 1820, and settled in Whitby. B. 5 June, 1840, in the Tp. of Whitby, Co. Ontario. Ed. at the High Sch., Whitby. M., Feb. 1867, to Mary Lydia Holman, of New York. Was Reeve and Deputy Reeve for six years. Is Presdt. of the Co. of Ontario Agricultural Soc., and of the Dominion Shorthorn Breeders' Association, and a dir. of the American Clydesdale Asso. and the Shropshire Sheep Asso. of the United States. First returned to Leg. Assem. at g. e. 1879 and re-elected at g. e. 1883 and 1886. A Liberal.—Brooklin, Ont.

EVANTUREL, FRANCIS EUGÈNE ALFRED, LL.B. (Prescott)

Eldest s. of the Hon. F. Evanturel, who was Minister of Agriculture in the Macdonald-Sicotte Administration of Can. in 1862, and grands of Francois Evanturel, who, after serving in the French army of Napoleon Bonaparte, and taking part in some of his great battles, settled in Can., and died at Quebec, B. at Quebec 31 Aug., 1849. M., 1873, Louisa, grand-daughter of the late Judge Van Felson, Quebec. Ed. at the Seminary there. Studied law at Laval Univ., and graduated there in 1870. Called to the Bar, P.Q., 1871, and, after practising in Quebec for two years, entered the Civil Service at Ottawa. Resigned in 1881, when he settled in the Co. of Prescott, where he now practises his profession. An unsuccessful candidate for present seat at g. e. 1883. First returned to Leg. Assem.
