

Of the Honorable Mr. Justice *Prince* and others, of the Township of *Korah*, in the Province of *Ontario*; praying that another steamer may be placed upon the Mail Service along the North Shore of *Lake Superior*.

Pursuant to the Order of the Day, the House resumed the adjourned debate on the motion of the Honorable Mr. *Campbell*, viz.: That the Bill intituled: "An Act respecting "Insolvency," be now read a second time.

After further Debate,

The question of concurrence being put thereon, the same was resolved in the affirmative, and

The said Bill was then read a second time accordingly.

Whereupon the Honorable Mr. *Campbell* moved, seconded by the Honorable Mr. *Kenny*,

That the said Bill be referred to a Select Committee, composed of the Honorable Messieurs *Ritchie*, *Hazen*, *Sanborn*, *Bureau*, *Ross*, *Allan*, *Ryan* and the mover, to meet and adjourn as they please.

After Debate,

The question of concurrence being put thereon, the same was resolved in the affirmative, and

*Ordered* accordingly.

Pursuant to the Order of the Day, the Bill intituled: "An Act to detach the Township "of *Doncaster* from the County of *Montcalm*, and to attach it to the County of *Terrebonne* "for electoral purposes," was read a second time.

On motion of the Honorable Mr. *Dumouchel*, seconded by the Honorable Mr. *Cormier*, it was

*Ordered*, That the forty-second Rule of this House be dispensed with, so far as it relates to this Bill, and that the same be read a third time presently.

The said Bill was then read a third time accordingly.

The question was put whether this Bill shall pass?

It was resolved in the affirmative.

*Ordered*, That the Clerk do go down to the House of Commons and acquaint that House that the Senate have passed this Bill without any amendment.

The Order of the Day being read for the second reading of the Bill intituled: "An "Act respecting the Ocean Mail Service."

The Honorable Mr. *Campbell* moved, seconded by the Honorable Mr. *Mitchell*,

That the said Bill be now read a second time.

After debate,

The question of concurrence being put thereon, the same was resolved in the affirmative, and

The said Bill was then read a second time accordingly.

*Ordered*, That the said Bill be read a third time to-morrow.

A Message was brought from the House of Commons by their Clerk to return the Bill intituled: "An Act to amend the Act passed by the Legislature of the late Province of "Upper Canada intituled: 'An Act to incorporate a Company under the style and title "of 'The British America Fire and Life Assurance Company,'" and to acquaint this House that they have passed the said Bill without any amendment.

A Message was brought from the House of Commons by their Clerk, with a Bill intituled: "An Act respecting the Office of Queen's Printer and the Public Printing," to which they desire the concurrence of this House.

The said Bill was read for the first time.

On motion of the Honorable Mr. *Campbell*, seconded by the Honorable Mr. *Mitchell*, it was

*Ordered*, That the said Bill be read a second time to-morrow.
