

SUPPLEMENTARY SUMMARY OF EVIDENCE

In the case of No.E.4451, Private Marcel LARIVIERE, of the Royal 22e Regiment, on the strength of No.1. Canadian Division Infantry Reinforcement Unit, a soldier of the Canadian Army (Overseas)

FIRST WITNESS FOR THE PROSECUTION CONTINUED

1 Fin Striped Brown Suit
1 Brown Trilby
1 Silk Tie
1 Rubber Macintosh
1 Pr. of Leather Gauntlets

I left my uniform at these premises after changing into the a/m clothing. Since that time I have been staying with a Girl friend in London, whose name and address I decline to divulge. I sold the Macintosh and Leather Gauntlets to a civilian on the Street. I do not know who this man was. I was arrested at Charing Cross Rd in a cafe by the Civilian Police at 2330 hrs Jan 12th. 43"

SECOND WITNESS FOR THE PROSECUTION DOCUMENTARY.

973891 LAC Honeyman W.M., hut 22A, HQ, RAF, Pitreau, Rosyth, Scotland, made the following statement which is now read to the accused:

"I arrived in London on seven days leave on 2-1-43 and engaged a room at the Union Jack Club, Waterloo, Room #240. On 6-1-43 I met a French Canadian soldier, whom I believe to be from the R 22e R, & by the name of Marcel Lariviere. We had breakfast together at the Union Jack Club, and Lariviere stated that he had not had any sleep the previous night as he was on night duty. He further stated that he was a despatch rider stationed at Trafalgar Square. During this conversation I offered this soldier the use of my room at the Union Jack Club so that he might have a rest in the afternoon. He accepted this invitation & I took him up to the billet & left him there at about noon of the above date. On returning to my lodgings at approx. 1630 hrs 6-1-43 I found that the above mentioned soldier had departed & the following civilian clothing belonging to me had disappeared:

1 Brown Pin striped Suit - Serge
1 " Trilby Hat
1 Striped Silk Tie
1 Rubber Macintosh
1 Valet Shaving Set.
1 pr. Gauntlet Leather Gloves.

There were no identification marks on this clothing, but it was all practically new material. I would describe the a/m soldier as:-

5' 2"
130 lbs.
Slight build
Dark Brown Hair worn long and brushed back
23 years old
Spoke with French Canadian Accent.
