DAIRY PRODUCTS

FURTHER RESTRICTIONS ON IMPORTATION INTO UNITED STATES

On the orders of the day:

Mr. H. R. Argue (Assiniboia): I should like to direct a question to the Minister of should like to direct a question to the [Mr. Fulton.]

Trade and Commerce arising out of a news report this morning. Has the United States government placed further restrictions on the importation of Canadian dairy products? If so, is the government prepared to make strong protests to the United States authorities?

Right Hon. C. D. Howe (Minister of Trade and Commerce): Word has reached this department this morning that a complete embargo on the import of dried whole milk, dried buttermilk and dried cream becomes effective April 1. The existing controls on other commodities and products remain unchanged. These include the import embargo on dried skim milk, butter, flaxseed, linseed oil, peanuts, peanut oil and rice. The import quotas on cheddar and other types of cheese remain at the levels already in effect.

In answer to the second part of the question, I would say that the government has forwarded three strongly worded protests, the last within four weeks, and the government will continue to protest as effectively as diplomatic procedure will permit.

INTERNATIONAL WHEAT AGREEMENT-INQUIRY AS TO RESULT

This being the last day of that conference, is the minister in a position to say whether or not he is still hopeful that an agreement is going to be reached?

Right Hon. C. D. Howe (Minister of Trade and Commerce): Well, Mr. Speaker, I just returned to Ottawa this morning. I have tried to get in touch with our representatives at Washington, but I have not been able to do so. I have heard indirectly that the meeting arranged for today has been adjourned for 24 hours. I presume that indicates that the representatives are still hopeful. I do not think I should tell the house whether I am optimistic or pessimistic about an agreement, because I do not think it makes any difference. As soon as a decision is arrived at I shall be glad to communicate it to the house.
