# CONSTRUCTION OF REPLICA OF "GRANDE HERMINE"

### Question No. 1,201-Mr. Coates:

Was Davie Brothers Limited, of Levis, Quebec, awarded the contract for the building of a full-size replica of Jacques Cartier's ship *Grande Hermine* and, if so (a) were tenders called for this contract (b) what were the names of the firms who submitted tenders (c) what were the amounts submitted by each firm?

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): Davie Brothers Ltd. of Levis, Quebec, was awarded the contract for the building of a full size replica of the Grande Hermine without tender call after L'École Polytechnique of Montreal, who were engaged by the Department of Northern Affairs and National Resources to provide detailed specifications for the reconstruction, advised, with the concurrence of Mr. H. I. Chapelle, curator of the new museum of history and technology of the Smithsonian Institution and an internationally recognized authority on historical shipbuilding, that Davie Brothers Ltd. were the only shipbuilding company with the capacity to meet the required tight construction deadlines and the rigorous standards for authentic replicamaking. Consequently, Davie Brothers Ltd. was invited to submit a firm price quotation. On behalf of the department, Deputy Commissioner Robert Shaw of Expo '67 convened an ad hoc group composed of Messrs. Fred Rhuland of Smith-Rhuland Ltd., of Lunenburg, who built replicas of the Bounty and Bluenose; George H. Cuthbertson, Toronto naval architect; R. A. Engholm, immediate past commodore of the Royal Canadian Yacht Club; and Commodore O. C. S. Robertson. The group recommended acceptance of the submission.
